VENDOR AGREEMENT

This Vendor Agreement is between the "Organizer "Grace Bible Fellowship of Antioch and the "Vendor" _____.

The Organizer will be hosting an event entitled Community Yard Sale (the "Event") and is permitting certain vendors to sell at the Event.

1. SCOPE:

This Agreement sets forth the terms and conditions whereby Vendor will be permitted to sell certain items at the Event.

Neither Party is by virtue of this Agreement authorized as an agent, employee, or legal representative of the other. Neither Party shall have the power to control the activities and operations of the other. The Parties' status at all times will continue to be that of an independent contractor relationship.

2. GOODS:

Vendor is engaged in the business of selling the following goods (the "Goods"):

Vendor hereby warrants that the Goods being sold are of the utmost quality, healthy, and safe to be sold under all applicable state and federal laws.

3. PAYMENT:

Organizer agrees to provide space for Vendor at the Event at a cost of \$40.00, which space shall be chosen in advance. The Organizer does have tables, chairs, and canopies for rent (1 table, 1 chair, and 1 canopy = \$10). Payment can be made by cash, or by check made out to "Grace Bible Fellowship" or call the administrative office (925) 522-2017 to make a credit card payment.

- 3a. Space Rental: \$40.00**
- 3b. Rental Package (space, canopy, table, chair): \$50.00**

4. VENDOR RULES/REGULATIONS

- Vendor shall be permitted to set up 2 hours before the Event on Saturday, October 21st.
- Vendors utilizing helium and/or propane tanks must secure, maintain, and use equipment in compliance with the Contra Costa County Fire Protection District regulations.
- Vendors providing food and/or drinks must follow Contra Costa County Environmental Health Department. Please forward a copy of your Permit/Certificate from the Health Department with your Agreement.
- Vendors are responsible for obtaining Contra Costa County Fire Protection District required permits, and for payment of all applicable taxes. Please forward a copy of your Permit (s) with your Agreement.
- Organizer will not provide additional insurance coverage and will not be responsible for any damage or loss.
- Vendor shall be responsible for maintaining the space provided by Organizer in a clean and orderly manner. Vendor shall be responsible for all trash removal at the close of the Event. If Vendor does not keep the space clean, Organizer may undertake the cleaning services and charge Vendor the amount needed.

5. LIMITATION OF LIABILITY

To the extent it is lawful, neither Party shall be liable to the other Party in contract, tort, negligence, breach of statutory duty or otherwise for any loss, damage, costs, or expenses of any nature whatsoever incurred or suffered by that other Party of an indirect or consequential nature including without limitation any economic loss, data loss, loss of goodwill, or other loss of turnover, profits, or business.
